BOARD OF HEALTH October 14, 2021

On Thursday, October 14, 2021, at 7:34 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, Church Road.

Before the meeting was opened, the Pledge of Allegiance was recited.

The meeting was called to order by Chairperson, Audrey Balogh, and the following statement was read at the commencement of the meeting.

Adequate notice of this regular meeting was given pursuant to the Open Public Meetings Act, by the Township Clerk on December 10, 2020, by:

- Posting such notice on the bulletin board at the Municipal Building and on the Holland Township website.
- 2. Mailing the same to the Hunterdon County Democrat and the Express Times.

Donna Lizanich made a motion, seconded by Tony Szumski, to accept the minutes of August 12, 2021. Motion carried.

Septic System Alteration Waiver, Block: 16.01 Lot: 4, 220 Rummel Road, Milford, NJ. Kurt Hoffman is requesting a Waiver to correct a malfunctioning system with no expansion. The design is in full conformance with 7:9A, "Standards for Individual Subsurface Sewage Disposal Systems", except for the waiver requested. The proposed disposal bed will be only 61 feet from the existing well which does not meet the minimum set back requirement of 100 feet. The distance can be reduced to 50 feet if there is 50 feet of casing in the well.

The engineer has provided documentation that an Ultra Violet treatment device has already been installed on the well for added protection. A water test for coliform shall be done to ensure the device is working.

After discussion, Christopher Balogh made a motion to grant the waiver for Block 16.01 Lot: 4 for the distance of the proposed disposal bed being only 61 feet from the existing well. A passing coliform test from a NJ certified lab must be provided to the County Health Department once the UV light is installed. Donna Lizanich seconded the motion. A roll call vote was taken. Pearl Hammerstone, aye; Audrey Balogh, aye; Christopher Balogh, aye; Tony Szumski, aye; Donna Lizanich, aye; Lisa Mickey, aye and Karen Young, aye; It was a unanimous *aye* vote to grant this waiver.
