Kurt Hoffman was in attendance, requesting a Waiver for a septic system alteration with no expansion on an existing three bedroom dwelling. He proposes a Norweco ATU to address site constraints and for greater effluent treatment.

1. There is a regional zone of saturation less than 24 inches in soil log #1. The regional zone of saturation is 18 inches in soil log #1. The design is shown with 24 inches of separation which is more than the minimum requirement of 18 inches of separation from the regional water table to the proposed level of infiltration for an ATU system.

Tony Szumski made a motion to grant this waiver on Block: 11.03 Lot: 12, items 1. The use of the Advanced Treatment Unit will require a maintenance contract for the life of the system, deed notice and auto dialer certification The motion was seconded by Christopher Balogh.
