Minutes of the March 2017 meeting were approved.

Bunn Valley District Update

Larry LaFevre stated that the application is about ready to be submitted to the New Jersey Historic Preservation Office (NJHPO) early this month for review and approval.

PennEast Pipeline Update

Larry said he received a call from Ms. Kaitlin Pluskota. She is employed by AECOM, an engineering firm, which is sub-contracted by PennEast to perform Section 106 review (historic research). Larry mentioned that Ms. Pluskota sent him an email, requesting documentation on 34 individual lot and block numbers. Blocks 13 – 27 are either on or near the pipeline route. This Commission has documentation on only about 9 of these. Larry asked whether or not the documentation should be provided. The consensus is that it should be up to each landowner to give permission to the Commission to release the documentation.

Publication Update

Kathy Sciarello passed around a copy of her new, fourth publication; "Early Life and Traditions of Holland, N.J. - 1896 -1902". Copies will be ordered and made available for purchase in the Clerk's Office. Kathy said she already commenced work on a fifth local history publication.

Presentation by Jim Walter

Jim Walter, Director of the Durham Historical Society, brought some historic books that he considered donating to the Commission. These included:

Jim described his current research interest in the iron company ferry, between the iron furnace in PA and the railroad at the box factory in NJ. He asked for help in locating a large iron ring that would have been attached to the rocks in New Jersey, and used as part of a mechanism to bring the ferry back and forth across the Delaware River.
