RE: Holland Township – Fiberville Tax Appeal (Block 2, Lot 1.02)

As you are aware, the tax assessment on the Hughesville paper plant property is currently under appeal.

STATUS OF TAX APPEALS AND SETTLEMENT

Fiberville has appealed three years (2014, 2015, and 2016) of their tax assessments. The current assessment is \$1,033,500.

Fiberville initially made a settlement offer to reduce the assessment for all appealed years to \$250,000. This would result in a refund of approximately \$60,000. Through negotiation, Fiberville has made a counter-offer for the appealed years as follows:

2014: Withdraw (no refund)

2015: \$750,000 assessment (refund of \$7,257.60) 2016: \$500,000 assessment (refund of 13,806.98)

2017: \$250,000 assessment

Total Refund: \$21,064.50
