-RESOLUTION-Authorizing the Township Attorney to draft a letter to the owner of the property located at 499 Shire Road

Authorizing the Township Attorney to draft letter to the owner of the property located at 499 Shire Road

WHEREAS, Holland Township received information that that an approximately twenty four (24) inch high stone wall had been constructed along the edge of the road at the property located at 499 Shire Road in the Township (the "Property"); and

WHEREAS, the wall and portions of the house immediately adjacent to the wall are located in the public right-of-way; and

WHEREAS, the Public Works Department expressed concerns that the wall will impede snow removal from the roadway and cause safety problems; and

WHEREAS, in or about February 2016 the Township requested the property owner remove the wall; and

WHEREAS, the property owner objected to removing the wall, expressing both aesthetic and safety concerns; and

WHEREAS, the Township requested that the municipal engineer conduct an investigation of the site, the safety concerns and the issues raised by the property owner and advise the Township of the proper actions to be taken, considering both public safety and the concerns of the property owner; and

WHEREAS, upon further investigation by the Township Engineer, it was ascertained that the wall and a portion of the residence on the Property is in the public right of way; the roadway adjacent to the Property curves sharply and the house is located only several feet away from the roadway;

WHEREAS, in an effort to reach an amicable solution, the Municipal Engineer met with the property owners and learned that the they have owned the property for about sixteen years and that it is their understanding that a lower version the stone wall in some manner has existed since at least 1964; and

WHEREAS, the property owners provided the Township Committee with an "historic" undated picture of the residence and the wall which depicts a row of stones no more than 6 inches high in the place where the wall now exists; and

WHEREAS, the Township Committee and the Township Engineer recognize that the current wall provides some protection to the residence from an errant vehicle; and

WHEREAS, however, pursuant to a memo dated April 4, 2016 (which is attached hereto) the Township Engineer has concluded that the wall as constructed presents a high hazard to motorists on Shire Road due to the wall's close proximity to the edge of the roadway; and

WHEREAS, the Township Engineer has recommended that the wall be completely removed; and

WHEREAS, the Township Engineer has determined that a guiderail cannot be placed on the sharp curve of Shire Road adjacent to the subject property due to the location of the residence on the Property; and

WHEREAS, the Township Engineer has recommended that the Township explore the option of installing advanced warning signs and object markers on Shire Road in order to protect the residence on the Property; and

WHEREAS, the Township will be making improvements to Shire Road in 2016 and the wall, as expanded, will hinder and interfere with the construction project; and

WHEREAS, the Township Committee recognizes that there is no perfect solution in this matter, that the safety of the motoring public must be balanced against other considerations, that leaving the wall in place exposes persons operating vehicles on the road to a significant risk and hazard, that removing the wall may increase slightly the risk of damage to the house or its occupants, but that signage and/or other warnings may mitigate against risk to the house and its occupants so that when the risks are weighed against each other the most prudent course is to remove the wall which has been improperly located in a public right-of-way, although tolerated for a considerable period of time.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Committee of the Township of Holland, County of Hunterdon, State of New Jersey hereby authorize the Township Attorney to draft letter to the owner of the property located at 499 Shire Road advising that the wall at the edge of the roadway is to be removed within 30 days and that if it is not removed, the Township will remove it.
