II. Farmland Preservation Applications:

- A. Brown: Final survey with metes and bounds & an updated title search were submitted to the State. State returned comments and surveyor agreed to changes
- B. Braun: (B15 Lots 2 & 22.01): No update
- C. Kerr: (B15 L1): 2nd appraisal ordered via N. Goldberg; HLT is checking if 10 month spread is too great; first appraisal has a date of value of June 15, 2015. Tom Rodriquez agreed to do an update at no additional charge.

III. Other Land Preservation:

- A. Silva Farm: B10 L43 (97.25ac) and B14 L20 (32.99ac): May re-apply for preservation. Family has questions; emails have been exchanged but no meeting set.
- B. Gombosi: (B25 L30, 48.5ac): John Alexis has contacted the SADC about purchasing and preserving the property. Larry gave John numbers from three recent appraisals and did not hear back.
- C. Suida: The new owner, Craig Rothenburg, has contacted the SADC about land preservation.
- D. Hoffman: Update on Hoffman Farm: Property previews will be held on 5/22/16 from 12:00-2:00 p.m and June 2nd from 12:00-2:00 p.m. Houses and barns will have pathways open to them. County may clear lime kilns prior to auction, roadway will be redone all the way back. Only registered bidders will be allowed. Open bid/absolute sale. Auction will be held on June 9th on Route 12 at the County Complex.

- E. Lauber: Has agreed to sell their landlocked property to the county.
- F. Schick: In current negotiations to possibly sell their landlocked property as well.
