January Minutes Were Approved

Farmland Preservation Applications:

- **Schafer/Cummins**, MPIG, (B6 L62.03, 20.99ac): Agreement for sale executed. Survey in process. HLT will handle title work.
- Smith, DE, (B15 L1.01 & L1.02, 41ac): Closing review in process.
- Schmied/Harder, (B6 L2 & L2.06, 116ac): Avram Schmied plans to sell the farm. Appraisals in process for SADC fee purchase.
- **Duff/Stone**, DE (B26, L26, 15ac): Accepted CMV of \$4700/acre. Working on subordination of mortgage. Survey on hold until this is resolved. Farm is for sale for \$750,000.
- Clark/Tomson, (B6 L60, 180ac): Per realtor have an offer for \$9000/acre. No update.
- Slate, (B24, L6, 65.88ac): Site visited Tuesday, April 4th. Slate resubmitted application to SADC. Direct easement, if SADC approves. Otherwise, MPIG to get Federal funds. Larry circulated earlier SADC map of the Slate farm showing proposed impact of PennEast pipeline. (Plans for pipeline are canceled.)

Other Land Preservation or Business

<u>Conservation Easement</u> – Larry showed a copy of the conservation easement for the Judith Johnson farm. Highly restrictive.

<u>K. Harrison Lot (B22, L118, 12ac)</u> – Larry said he received a call from Mr. Ken Harrison. Mr. Harrison is interested in selling his lot to Green Acres. However, he is receiving no response. Larry advised Mr. Harrison to reach out to Ms. Jackie Middleton, Director of Land Acquisitions, at Hunterdon Land Trust.

Gombosi Farm (B17, L24, 101.9ac) – Larry showed map of the Gombosi Farm. Owner wants to sell, not preserve.

<u>Rich Cain Horse Farm</u> – Larry mentioned that 15 12x12 matted horse stalls will be available for rent. Will be vacated by Kyley Dufek.

<u>New Township Logo</u> – Larry introduced an image of the new Holland Township logo designed by Committeeman, Robert Thurgarland.
