PURPOSE OF REQUEST

Holland Township desires to hire an animal control service provider who will facilitate the Township's needs. Applicants should have experience in the field and have any necessary licenses to carry out the services.

PERIOD OF CONTRACT

One (1) year contract from January 1, 2020 – December 31, 2020

CONTRACT FORM

The successful proposer shall be required to execute the Township's form contract, which includes the indemnification, insurance, termination and licensing provisions set forth in this RFP.

**DETAILED REQUIREMENTS OF THE
REQUEST FOR PROPOSAL FOR ANIMAL CONTROL SERVICES**

SCOPE OF SERVICES:

Any persons or firms interested in providing professional services to Holland Township (“Holland”) as defined in the New Jersey Statutes, N.J.S.A. 40A:11-2(6).

A. Animal Control Services Contract. An animal control service shall be hired for a term of 1 year following the Township Committee approval. Compensation will be agreed upon and determined by the Committee.

B. Standard Requirements of Technical Proposal.

The Proposer should submit a technical proposal which contains the following:

1. The name of the proposer, the principal place of business and, if different, the place where the services will be provided;
2. The age of the proposer’s firm and average number of employees over the past three years;
3. The education, qualifications, experience, and training of all persons who would be assigned to provide services along with their names and titles;
4. A listing of all other municipalities where services of the types being proposed were provided. Contact information for the recipients of the similar services must be provided.
5. A detailed plan for providing the proposed services;
6. Proof of professional liability insurance with coverage of \$1,000,000.;
7. Proof of any necessary professional license or certification from the State of New Jersey for all professionals assigned to the engagement;
8. Statement that the firm has Workers’ Compensation and Employer’s Liability Insurance in accordance with New Jersey law;
9. Statement that neither the firm nor any individuals assigned to this engagement are disbarred, suspended, or otherwise prohibited from professional practice by Any federal, state, or local agency;
10. An Affirmative Action Statement;
11. A completed Non-Collusion Affidavit;
12. A completed Owner Disclosure Statement;
13. A statement that the proposer will comply with the General Terms and Conditions required by

Holland and enter into the Holland Township standard Professional Services Contract;

14. A copy of the Proposer's Business Registration Certificate.
15. A statement that the respondent has read the Americans with Disabilities language that is part of the documents attached hereto and agrees that the provisions of Title II of the Act are made part of the contract. The contractor is obligated to comply with the Act and hold the Holland Township harmless.

Specialized Requirements of Technical Proposal:

- A. The proposer shall perform all of the necessary tasks of animal control.
- B. The service will include canvassing the municipality for the purpose of picking up and confining dogs that are running at large per NJSA 4:19-15.16
- C. The service will respond to calls from the Township regarding stray dogs.
- D. The service will pick up confined stray cats.
- E. The service will promote Trap, Neuter , and Return for feral cats and return them to the originating location when possible.
- F. The service will provide animal control agent duties required and outlined under NJSA 4:19-18 to 4:19-37.
- G. The service will respond to calls regarding injured or sick wildlife.
- H. The service will provide for and bear the expense of emergency treatment of injured dogs and cats not claimed by their owners.
- I. The service will shelter the dogs and cats apprehended in the Township at it's own facility and provide for their care according to NJAC 8:23A-1.11.
- J. The service will maintain accurate records of each cat or dog impounded or sheltered by it. A monthly report will be provided to the Township as well as the annual shelter/pound survey of stray animal intake and disposition.

APPLICANT'S/PROPOSER'S RESPONSIBILITY IN RESPONDING TO THE TOWNSHIP'S REQUEST FOR PROPOSALS FOR ANIMAL CONTROL SERVICES

COST PROPOSAL- Proposers should submit a cost proposal which would the annual contract costs as well as any additional fees that may be charged.

PROPOSAL EVALUATION- Holland Township will select the most advantageous proposal based on all of the evaluation factors set forth at the end of this RFP. Holland Township will make the award that is in the best interest of the Township based on cost and other considerations. Each proposal must satisfy the objectives and requirements detailed in this RFP. The features of the proposal, considered together with its economic and other benefits, will form the basis for the

evaluation process. The successful proposer shall be determined by an evaluation of the total content of the proposal submitted. The Township reserves the right to:

- a) Not select any of the proposals;
- b) Award a contract for the requested services at any time within 60 days of the selection of the most advantageous proposal. Every proposal should be valid through this time period.

PROPOSAL LIMITATIONS- This RFP is not intended to be an offer, order or contract and should not be regarded as such, nor shall any obligation or liability be imposed on Holland Township by issuances of this RFP. Holland Township reserves the right to refuse any proposal submitted.

USE OF INFORMATION- Any specifications, drawings, sketches, models, samples, data, computer programs, documentation, technical or business information and the like (“Information”) furnished or disclosed by Holland Township to the proposer in connection with this RFP shall remain the property of the Holland. When in tangible form, all copies of such information shall be returned to Holland upon request. Unless such information was previously known to the proposer, free of any obligation to keep it confidential, or has been or is subsequently made public by the Holland or a third party, it shall be held in confidence by the proposer, shall be used only for the purposes of this RFP, and may not be used for other purposes except upon such terms and conditions as may be mutually agreed upon in writing.

GENERAL TERMS AND CONDITIONS –

- A. Holland Township reserves the right to reject any or all proposals, if necessary, or to waive any informality in the proposals, and unless otherwise specified by the proposer, to accept any item, items or services in the proposals should it be deemed in the best interest of the Township.
- B. In case of failure by the successful proposal, Holland may procure the articles or services from other sources, deduct the cost of the replacement from money due to the proposer under the contract, and hold the proposer responsible for any excess cost occasioned thereby.
- C. The proposer shall be responsible for, shall keep, save and hold the Holland Township harmless from, shall indemnify and shall defend the Holland against any claim, loss, liability, expense (specifically including but not limited to costs, counsel fees and/or experts’ fees), or damage resulting from all mental or physical injuries or disabilities, including death, to employees or recipients of the proposer’s services or to any other persons, or from any damage to any property sustained in connection with this contract which results from any acts or omissions, including negligence or malpractice, of any of its officers, directors, employees, agents, servants or independent contractors, or from the proposer’s failure to provide for the safety and protection of its employees, or from proposer’s performance or failure to perform pursuant to the terms and provisions of this contract. The proposer’s liability under this agreement shall continue after the termination of this agreement with respect to any liability, loss, expense or damage resulting from acts occurring prior to termination.
- D. The proposer shall maintain sufficient insurance to protect against all claims under Workmen’s Compensation, General Automobile Liability and shall be subject to approval for adequacy of protection.

- E. Each proposal must be signed by the person authorized to do so.
- F. Where applicable, payments will be made upon approval of vouchers submitted by the successful proposer in accordance with the requirements of Holland and subject to the standard procedures of Holland.
- G. Holland is exempt from any State sales tax or Federal Excise Tax. In submitting its proposal, the proposer certifies that its total base proposal does not include any NJ State Sales Tax.
- H. The contract shall be in effect for one (1) year from date of award unless otherwise stated.
- I. Proposals may be emailed or faxed to the Purchasing Agent per the instructions.
- J. If awarded a contract, the successful bidder shall be required to comply with the requirements of N.J.S.A. 10:5-31 et seq. And N.J.A.C. 17:27, and shall submit evidence of appropriate affirmative action compliance prior to the execution of a contract.
- K. All services shall be performed within the United States of America.
- L. All proposals submitted shall include in the price any applicable permits or fees required by any other government entity that has jurisdiction to require the same.
- M. By submission of the proposal, the proposer certifies that the service to be furnished will not infringe upon any valid patent, trademark or copyright and the successful proposer shall, at its expense, defend any and all actions or suits charging such infringement, and will save Holland Township harmless in any case of any such infringement.
- N. No proposer shall influence or attempt to influence or cause to be influenced any Holland Township officer or employee to use his/her official capacity in any manner which might tend to impair the objectivity or independence of judgment or said officer or employee.
- O. No proposer shall cause or influence or attempt to cause or influence any Holland Township officer or employee to use his/her official capacity to secure unwarranted privileges or advantages for the proposer or any other person.

BASIS for AWARD CONTRACT/AGREEMENT for PROFESSIONAL SERVICES

The Township shall award all professional service contracts or agreements based on qualification, merit and cost competitiveness. Selection criteria will include:

1. Qualifications of the individual or firms who will perform the service or activity.
2. Experience and references.
3. Ability to perform the service or activity in a timely fashion, including staffing and the staff's familiarity of the service or activity.
4. Cost Competitiveness.
5. The Township reserves the right to conduct an interview or interviews with the prospective Professional to discuss the scope of the professional services as outlined in the applicant's/proposer's proposal.
6. All awards will be by resolution acted on by the Holland Township Committee.
7. All awards are subject to availability of funds.
8. This policy will include, but not be limited to, all of the above listed requirements.

GOODS, PROFESSIONAL SERVICE AND GENERAL SERVICE CONTRACTS

During the performance of this contract, the contractor agrees as follows:

The contractor or subcontractor, where applicable, will not discriminate against any employee or applicant for employment because of age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex. The contractor or subcontractor, where applicable will, in all solicitations or advertisements for employees placed by or on behalf of the contractor, state that all qualified applicants will receive consideration for employment without regard to age, race, creed, color, national origin, ancestry, marital status, affectional or sexual orientation, gender identity or expression, disability, nationality or sex.

The contractor or subcontractor, where applicable, will send to each labor union or representative or workers with which it has a collective bargaining agreement or other contract or understanding, a notice, to be provided by the agency contracting officer advising the labor union or workers' representative of the contractor's commitments under this act and shall post copies of the notice in conspicuous places available to employees and applicants for employment.

The contractor or subcontractor, where applicable, agrees to comply with any regulations promulgated by the Treasurer pursuant to N.J.S.A. 10:5-31 et seq., as amended and supplemented from time to time and the Americans with Disabilities Act.

The contractor or subcontractor agrees to make good faith efforts to afford equal employment opportunities to minority and women workers consistent with Good faith efforts to meet targeted Township employment goals established in accordance with N.J.A.C. 17:27-5.2, or Good faith efforts to meet targeted Township employment goals determined by the Division, pursuant to N.J.A.C. 17:27-5.2.

If any action or administrative proceeding is brought against the Township or any of its agents, servants, and employees, the Township shall expeditiously forward or have forwarded to the Contractor every demand, complaint, notice, summons, pleading or other process received by the Township or its representatives.

It is expressly agreed and understood that any approval by the Township of the services provided by the Contractor pursuant to this contract will not relieve the Contractor of the obligation to comply with the ADA and to defend, indemnify, protect, and save harmless the Township pursuant to this paragraph.

It is further agreed and understood that the Township assumes no obligation to indemnify or save harmless the Contractor, its agents, servants, employees and subcontractors for any claim which may arise out of their performance of this agreement. Furthermore, the Contractor expressly understands and agrees that the provisions of this indemnification clause shall in no way limit the Contractor's obligations assumed in this agreement, nor shall they be construed to relieve the Contractor from any liability, nor preclude the Township from taking any other actions available to it under any other provisions of this agreement or otherwise by law.
