

BOARD OF HEALTH
JUNE 14, 2018

On Thursday, June 14, 2018, at 7:30 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, Church Road.

Before the meeting was opened, the Pledge of Allegiance was recited.

The meeting was called to order by Vice-Chairperson, Audrey Balogh and the following statement was read at the commencement of the meeting.

Adequate notice of this regular meeting was given pursuant to the Open Public Meetings Act, by the Township Clerk on December 21, 2017, by:

1. Posting such notice on the bulletin board at the Municipal Building and on the Holland Township website.
2. Mailing the same to the Hunterdon County Democrat and the Express Times.

Also in attendance was Erica Busch, PE

Donna Lizanich made a motion, seconded by Jeffrey Waldron, to accept the minutes of May 10, 2018. Motion carried.

Septic System Alteration Waiver – Block: 13 Lot: 2.06 174 Mt. Joy Road, Milford, NJ

Erica Busch showed plans for a septic alteration to correct a malfunctioning system with no expansion. The design is in full conformance with 7:9A except for the proposed disposal bed will be only 80 feet from the existing well on this property which does not meet the minimum 100 foot setback requirement by code. The distance may be reduced to 50 feet provided there is 50 feet of casing in the well. The engineer provided a signed and sealed letter that on May 30, 2018 the casing was measured and it was determined the length to be 54 feet.

After discussion, Jeffrey Waldron made a motion to grant the waiver for Block: 13 Lot: 2.06 for the distance of the well to the proposed disposal bed, seconded by Christopher Balogh. A roll call vote was taken. Donna Lizanich, aye; Audrey Balogh, aye; Christopher Balogh, aye; Jeffrey Waldron, aye; Pearl Hammerstone, aye. It was a unanimous aye vote to grant this waiver.
