

**BOARD OF HEALTH  
AUGUST 9, 2018**

Audrey stated she hopes the weather is good for Saturday's Farm Market as last week there were only three vendors due to the rain. A flyer advertising the Farm Market was sent out the previous week, accounting for many new faces coming to the market last week.
