

BOARD OF HEALTH

May 9, 2024

On Thursday, MAY 9, 2024, at 7:05 P.M., the regularly scheduled meeting of the Holland Township Board of Health was held in the meeting room at the Municipal Building, 61 Church Road.

Before the meeting was opened, the Pledge of Allegiance was recited.

The meeting was called to order by Chairperson, Audrey Balogh, and the following statement was read at the commencement of the meeting.

Duane stated the McWilliams went to the Township Committee regarding the Nuisance Ordinance 195-5. Since there is no mention of a specific decimal meter testing in the ordinance, the dogs barking and the rooster crowing, they were advised to go back to their attorney for further assistance.

Christopher Balogh made corrections to the Board of Health Septic Waiver Checklist, which will be forwarded to the Township Attorney and Township Committee for final approval.

It will then be posted on the Holland Township website under the Board of Health. Christopher will send all Board of Health members a copy of the revised document.

Melissa Tigar told Pearl the Municipal Clerks were on a Zoom meeting with the County Health Department regarding new paperwork for temporary food inspections and food trucks. The County Health department must know ten days before an event, so there is enough time to do the inspection. Farm stands selling baked goods and jellies are not allowed. They must first apply to the State of New Jersey for a **Cottage Permit, then they can bake in their own home, instead of a commercial kitchen.**

Christopher Balogh made a motion to adjourn the meeting, seconded by Tony Szumski.
The meeting adjourned at 7:50 P.M.
