Farmland Preservation Applications:

- Schafer/Cummins, MPIG, (B6 L62.03, 20.99ac): Closing review.
- Schmied/Harder, SADC fee purchase (B6 L2 & L2.06, 116ac): Environmental inspection review.
- Clark/Tomson, (B6 L60, 180ac): The county & state are looking at this farm. No update.
- Slate, DE (B24, L6, 65.88ac): Title review and survey nearly completed.

Other Land Preservation or Business

Tilstra, B22/L52 (23.29 acres) Possible Green Acres. No update.

Gombosi, (B17 L24, 101.9ac) No update.

Braun, Larry LaFevre shared a survey of the preserved K. Braun farm (Spring Mills Road), with a 5-acre severable exception. John Bonham stated that this property was recently purchased by Reed Holdings, a land investment company. The same company also purchased the E. Boss parcel consisting of about 23 acres.

<u>International Harvester Auction</u> – Larry shared an article, "A Lifetime Defined by International Harvester", that appeared in the Lancaster Farmer magazine of February 17, 2024. The article featured an upcoming sale of an extensive private collection of artifacts. Six auctions are needed to liquidate the collection.
